Please read carefully, this is a Release of Liability & Waiver of Legal Rights

1. I acknowledge that participation in this event is HAZARDOUS and involves a great risk of physical injury or death. I expressly assume all risk associated with participation in, or training for the competition (the "Event") including without limitation, the risks and inherent dangers associated with skiing/snowboarding and riding the lifts. I understand that I have the opportunity to inspect any jumps, turns, gates, race courses and other features, and the area, prior to training for or participating in the Event and I assume the risk of all course conditions. I understand that a helmet is required for this competition.

2. In consideration of receiving permission to take part in the Event, I agree to release Buck Hill Inc., and its agents, employees, directors, officers and shareholders from any and all liability for personal injury, death or property damage which results in any way from negligence, conditions on or about the premises and facilities, the operations, actions or omissions of employees or agents of the area, or my participation in the Event or other activities at the area, accepting myself the full responsibility for any and all such damage or injury of any kind which may result.

3. To the extent I am signing on behalf of a minor, I hereby release Buck Hill Inc. from any and all liability for personal injury, death or property damage sustained by the minor which results in any way from negligence, conditions on or about the premises and facilities, the operations, actions or omissions of employees or agents of the area, or the minor's participation in the Event or other activities at the area, accepting myself the full responsibility for any and all such damage or injury of any kind which may result.

4. I further agree to defend, indemnify and hold harmless Buck Hill Inc. from any and all claims, demands, losses, damages and liabilities with respect to personal injury, death or property damage arising from my or a minor on whose behalf I signed, participation in the Event or other activities at Buck Hill Inc. I promise not to sue the Buck Hill Inc. and further agree that if anyone is physically injured or property is damaged while I am engaged in this Event I will have no right to make a claim or file a lawsuit against the Buck Hill Inc.
